#### **Old business**

N. Sims gave an update on attempts to have interstate signage noting the Mid-Illinois Medical District through the Illinois Department of Transportation (IDOT). N. Sims informed the committee that IDOT has informed him that these signs violate their internal policy. N. Sims informed the commission that he has spoken with local legislators and there is the possibility of seeking a legislative solution.

#### **New Business**

Mike Southworth from Hart, Southworth & Witsman was in attendance to discuss how the Medical District could utilize its bonding authority to assist development projects. M. Southworth discussed the differences between a pure government bond and a private activity bond and how the MIMD can be a conduit to provide private activity bonds to developments within the District. The Commission was informed that the MIMD can provide federal tax exempt bonds but could partner with the Central Illinois Economic Development Commission for double exempt bonds for federal & state of Illinois taxes. The Commission was also informed that TIF funds could be used to pay the employers portion for the State's workforce housing program.

C. Warren informed the Commission that the Auditor General's Office was performing the routine audit on the Commission.
